Required Minimum Distribution - What is it?

Required Minimum Distributions (RMDs) are the minimum amounts you must withdraw from your retirement accounts each year. You generally must start taking withdrawals from your traditional IRA, SEPO IRA, SIMPLE IRA and retirement plan accounts when you reach age 73. These withdrawals are added to your income for that year and will be subject to federal and state taxes. Roth IRAs do not require withdrawals until the death of the owner; however,

beneficiaries of a Roth IRA are subject to the RMD rules.

Several strategies are available to avoid taxes on your RMD:

- 1. Donating to qualified charities: Qualified Charitable Distributions (QCDs) allow you to transfer money from an IRA to an eligible nonprofit organization, 501(c)(3), without being taxed. Your IRA custodian must agree to transfer the funds to your chosen charity(ies) on your behalf. You can't donate directly. You can't claim that donation as a charitable deduction on your taxes. You can check if your charities qualify for this by using Charity Navigator to see if the charity is a 501(c)(3).
- Rolling your account balance into a Roth IRA: Keep in mind that converting a traditional IRA to a Roth IRA doesn't mean you avoid taxes completely. You'll owe ordinary income taxes on any assets you roll over.
- 3. Purchasing an annuity (Qualified Longevity Annuity Contracts) with money from your IRA: This removes this amount from your RMD calculations. You don't have to begin receiving payments from the annuity until age 85. At this point they'd be subject to income tax.

Discuss these options with your financial advisor for more details.

The Teachers Retirement Association board appointed Mary Broderick in January to fill the open Retired position. Marti Zins resigned in October for personal reasons. The Education Minnesota Retired board supported Mary's appointment to the retired position. She will complete Marti's term, which ends in 2025, and retired TRA members will then elect the next retired trustee.

Mary brings a wealth of experience to the TRA board including:

- Served as an active trustee from 2007 until 2019. She left the TRA board when her term ended and retired from teaching.
- Served as President of the St. Cloud Education Association for 22 years, having served on the bargaining team before that.
- Has been a leader in the Minnesota AFL-CIO as a member of its executive board since the merger of MFT and MEA.



Mary described her previous experience on the board as rewarding. "TRA meetings were energizing, with the opportunity to work, and learn from, a lot of really smart people who worked on a common goal, by brainstorming and problem solving together to maintain the sustainability of the fund." During the 12 years that Mary served on the TRA board as an active member, she said,

"Marti was an amazing mentor. She is so knowledgeable in both national and state pension issues.

I learned how to lead and keep focused on our fiduciary responsibilities. Working closely with her, she taught me to be an active listener and that when you see something isn't right, you don't waver on your principles. I

value her experience and leadership."
