## NEA Board of Directors By Judy Rohde



This past summer at the NEA Retired Annual meeting, held just before the NEA RA in Orlando, I was re-elected to continue to represent NEA Retirees for another term on the NEA Board of directors (BOD). I am one of six retired members to serve on the 170 member NEA BOD to represent NEA Retirees. I will serve for three more years. Next to the NEA Representative Assembly, the NEA BOD is the highest ruling body for NEA. We meet four times a year in person in addition to numerous virtual meetings.

### Lobbying on The Hill

Before each NEA BOD meeting in D.C., we lobby all of our Minnesota representatives and senators. The most current issues we have lobbied on include:

- Support the Equality Act
- Invest in helping all our students succeed
- End unfair GPO/WEP penalties & strengthen Social Security for all

### Children impacted by war

NEA has been working with and through Education International (EI), the global union federation of educator unions, to speak out about the impact of this war on the children of the region and around the world. NEA is a founding member of EI and its largest organization. EI is the only global union federation in the world that has member organizations in both Israel and Palestine.

NEA believes that all people, no matter their religion, spoken language or place of birth, have a fundamental right to live free of violence and war. The horror of what Hamas terrorist did can never be justified.

### Watch for it – The film "Radical"

The NEA BOD was given an opportunity to see a special screening of a new movie: "**Radical**". The movie is both inspiring and heartbreaking simultaneously. The stars of the film are the children who are inspired by an educator who teaches them not just the curriculum or how to pass the test, but how to think and believe in themselves.

### From the NEA General Counsel – Alice O'Brien

NEA is involved in making sure educators have the right to teach honest history and fight for educators' right to teach curriculum that reflects our students. NEA defends teachers who face severe disciplinary consequences, including termination, for teaching critical thinking skills and empathy. General Counsel O'Brien highlighted the NEA's commitment to ensuring educators are paid a fair, living wage and have the necessary accommodations they need.

### American Indian/Alaska Native Observance

During this observance, key points were made:

- 92% of native students are in public schools
- A challenge is to find and preserve native language
- The native language got us out of two world wars
- We need to help students to be comfortable to be themselves

## **Legislative Action Committee**

As you probably know, the Legislative Commission on Pensions and Retirement (LCPR) makes recommendations to the full Legislature where decisions about public pension benefits and contributions are made. Two significant changes made to TRA during the 2023 session:

Lowered the Normal of Age of Retirement to 65 beginning in 2025

• Added a 1.4 percent one-time payment in 2024, in addition to the 1.1 percent Cost of Living Adjustment (COLA) already in statute.

It is significant that the LCPR has held meetings during the interim to prepare for the 2024 session; it suggests that they see a serious need for change. Active members have been letting them know how unhappy they are with requirements for full pension benefits.

In 2018, the TRA fund looked unsustainable and the LCPR put together a bill to preserve the defined benefit system we have for future retirees. It included:

- Reduced TRA COLAs to one percent each of the next five years
- Increased COLAs each of the following five years by .1 percent
- Raised some employer and employee contribution rates

At that time, inflation was running about two percent annually but we retirees supported the bill in order to preserve a defined benefit pension for future retirees.

Retired advocates heard assurances in 2018 that COLA changes might need to be reconsidered during the next 10 years, if circumstances changed. Circumstances have changed. Since 2020, inflation rates are much greater than two percent (Social Security COLA for 2023 was more than eight percent.) State revenues had a very large surplus last year, and state revenue forecasts for 2024 are also running significant surpluses

Those who retired before and since 2018, have suffered huge losses in the value of TRA benefits. Current law caps COLAs at 1.5 percent in 2028 and inflation continues to run well above that rate. While the one-time bonus payment we will receive in 2024 will help and is appreciated, it will not be added to the base to calculate future COLAs.

If you care about the value of your pension benefits going forward, you need to speak up. Talk to Legislators who go to St. Paul in February, and watch for emails and newsletters from us about:

- Meetings of the LCPR.
- Attend the Education Minnesota Political Conference on February 2-3.
- The Retired Legislative Conference (sometime in March)

## **Membership Update**

Beginning with the 2015-16 school year, active Education Minnesota members who are 55 years of age or older, have at least 10 years as a member of Education Minnesota (does not have to be continous), qualify for a public pension and were an active member at the time of retirement should qualify for retired membership at **no additional cost**. However, membership is not automatic, **retirees must register for the retired membership**. There are many retirees who meet the qualifications for continuous membership but have not registered. Do you know any of these retirees? Please ask them to register online at https://educationminnesota.org.

By staying connected to the union, retirees have access to professional development and member benefits including NEA life insurance they may have purchased. In addition, retirees who do day-to-day subbing will continue to have liability insurance under the retired membership. Retirees are also a vital part of the union as we continue to fight for full funding of public education and improvements to our pension.

If retirees do not meet the continuous membership qualifications, they can join through a paid membership. Currently a paid retired membership is one-time fee of \$350 for teacher and \$275 for ESPs. If you have any questions, please contact Stephanie Berg at <u>stephanie.berg@edmn.org</u>.



## **Education Minnesota Retired Fall Breakfast**

The Education Minnesota Retired Fall Breakfast was held on Thursday, October 19 from 9-11:00 a.m. at the St. Paul RiverCentre. This event is a wonderful activity to attend. For a very low price, it includes a full breakfast, updates on current political issues from Education Minnesota staff and time to network and to visit with other Education Minnesota Retired colleagues.

A "welcome" was extended by President Wes Tessman. Around 30 members in attendance introduced themselves as well. Education Minnesota staff shared the

importance of the upcoming school board elections which will be occurring throughout the State. Unfortunately, a toxic ideology sweeping across the country that wants to deny students the freedom to learn and be themselves and to take away educators' tools has landed here in Minnesota. One group, Moms for Liberty, has called for removing mental health care from schools. Another, the Minnesota Child Protection League, spreads homophobic conspiracies targeting schools and educators. These groups are funding and endorsing candidates in school board races statewide.

Together, we can raise our voices as Minnesotans and vote for candidates that will defend our students' freedom to learn an honest history of the United States, both the good and bad, and their freedom to be safe and welcome as their authentic selves in their local public schools.

Retiree Jeanne Brown-Kruesel serves on the Education Minnesota Pension Advisory Group. She gave a presentation on what the group is working on and the health of Minnesota's TRA. Quality teachers and qualified education personnel will not remain in the Minnesota education work force if the profession does not have quality pay and benefits.

Education Minnesota Secretary Treasurer Rodney Rowe also spoke on the health of educators in today's Minnesota schools.

## PERA Update

The PERA funds' investment return for the fiscal year ending June 30, 2023 was 8.9%. The combination of an investment return that exceeded our assumed return and member and employer contributions sufficient to help reduce the unfunded liability will help slightly improve the health of our General Employees Retirement Plan (the "Plan") as measured on June 30, 2023. We are waiting for final reports, but expect the Plan to be about 85% funded. More importantly, the Plan is projected to improve towards being fully funded within the next twenty years.

In addition to those positive steps, the Legislature allocated most of the money they made available to PERA to help improve the funding health of the Plan. PERA advocated that a higher priority be placed on funding existing benefits and reducing the unfunded

liability rather than a temporary contribution reduction or increasing benefits.

PERA General Plan retirees will receive a 1.5% benefit increase effective January 1, 2024. Our Board acknowledges that retiree benefit increases are not keeping up with recent inflation increases. However, although progress has been made, it is clear that the Plan is not currently in a position to either lower member or employer contributions or increase member benefits unless those changes are fully funded by the Legislature

In 2023 the Legislature did provide direct funding for a retiree benefit increase. In addition to money to reduce the Plan's unfunded liability, the Legislature fully funded a one-time non-compounded benefit for retirees that will equal 1% of their annual benefit amount. Basic members in PERA General will receive 2.5% of their annual amount. This amount will be paid to most of our retirees in early 2024.

Generally speaking, PERA's Board will support certain benefit increases provided the changes are equitable within our membership and come with appropriate funding. PERA will want to ensure that any proposal to increase benefits comes fully funded so that the sustainability of the Plan is not further threatened.

## **Regional Meetings**

This spring your Retired board was able to host two regional meetings for our retired members. On Monday, September 11, we held a regional meeting in the Windom area at the BARC Center. Then we moved to the Rochester area on Tuesday, September 12 for a meeting at the Holiday Inn South Rochester. Five informational sessions were held at each meeting including:



- Who We Are and What We Do an introduction to your Retired Board, our committees and activities.
- Legislative issues
- The NEA Member Benefits Program
- TRA/PERA presentation
- Update on outside groups trying to influence school board elections and other local elections.



Participant feedback was good for both regional meetings. The committee will be meeting to discuss the timing and locations for future regional meetings.

### Foundation Contribution

Education Minnesota has established a nonprofit, charitable organization whose purpose is to provide grant funds to members and certain other nonprofit groups.
